Removal of place from Queensland Heritage Register

Council refers to your request dated 22 April 2024, seeking Council submission on the Removal of a place from the Queensland Heritage Register.

Application Details

Proposal: Removal of place from Queensland heritage register

Street address: Henlein & Co (Best & Less), 408-410 Flinders Street,

Townsville

Real property description: 33 T11860

The submission is made under s.42 of the *Queensland Heritage Act 1992*. It is Council's understanding that the proposed portion of the property that is to be removed from the register satisfies the cultural heritage criteria as specified in the Act (s.35).

Townsville City Council does not object to the proposal to remove from the Queensland Heritage Register the specified portion of the property at 408-410 Flinders Street, Townsville, which was built in 1960 as an extension (with frontage to Ogden Street) to the original 1901 building with frontage to Flinders Street. It should be noted that Council would not be supportive of any proposal to remove the 1901-built structure from the Queensland heritage register.

Council has no information to indicate that this rear 1960-built portion of the property has any heritage significance sufficient to meet any of the criteria in s.35 of the *Queensland Heritage Act 1992*, or the criteria for places that are listed in 'Schedule 7 - Places of cultural heritage value' in the Townsville City Plan.
